I'm sure you won't. I have added the premiers of every province, territory and the representative of the Assembly of First Nations to this document. Addendums are in place if anything needs to be changed/added regarding the stances of various provinces. The Pipeline/National Hydro agreement has been finalized and is not as personalized of a deal as the USMCA and as such we will be bringing the finalized version directly to you all tomorrow (addendums are in place if any last minute changes are to be made for this document as well).

FEDERAL PROVINCIAL AGREEMENT TO ISSUES REGARDING USMCA

The federal government will grant monetary compensations to the following provinces affected by USMCA listed below.

Assembly of First Nations - Have made specific requests associated with the economic situation of First Nations communities in Canada overall and advocated for a Trade Union for First Nations individuals (see proceeding sections)

Quebec - has made a request of **500 million dollars** for the dairy farming industry

Newfoundland - has made a request of **4 billion dollars** for the dairy farming industry

British Columbia - has made a request of **500 million dollars** for the softwood lumber industry.

New Brunswick - has made a request of **100 million dollars** for the dairy farming industry

Alberta - has made a request of **68 million dollars** for the dairy farming industry

Prince Edward Island - Has not given a specific amount but will be compensated for specified losses.

Saskatchewan: Would not like to be compensated. Addendum _____

Manitoba: Would not like to be compensated. Addendum _____

Nunavut: Will see through with the formation of a Trade Union for First Nations People (see proceeding section)

North West Territories: Will see through with the formation of a Trade Union for First Nations People (see proceeding section) in addition to imposing a price cap on big pharmaceutical companies of maximum \$100 per dose to compensate for the USMCA forcing generic brands to have two extra years of research for a patent.

Ontario: has made a request of **100 million dollars** for the dairy farming industry

Nova Scotia: Has not given a specific amount but will be compensated for specified losses.

Addendum requests **50 million dollars** in compensation for the dairy farming industry.

Yukon: Will see through with the formation of a Trade Union for First Nations People (see proceeding section)

Equal Economic Opportunities for First Nations People

- The Prime Minister and federal government will routinely sit down to meet with leaders of First Nations communities regarding their associated economy and any investments pertaining to them, their land, or their resources
- To further provide business opportunity, Aboriginal representatives will be invited to sit at investment tables
- Any investments or developments involving Indigenous lands or culture should be given prior consent and permission from the First Nations community

Trade Union for First Nations People

- First Nations communities in Northwest Territories, Yukon, Nunavut and all such areas will be able to form this union in order to promote the exportation of products developed from natural resources associated with their lands and amplify their corresponding economy.
- The exportation of their products will undergo no duties when distributed.
- All products from this agreement will be listed as quality products, ensuring they cannot be appropriated.

In addition, funds will be provided to create economic liaison team to ensure that all compensations given to provinces will be used effectively. This will allow for further communication with federal government in regards to each province’s needs and demands. The teams will be comprised of both professionals within the economic analysis field as well a experts within the affected trade industry to accommodate each province’s unique assets.

The federal government also recognizes that further implementations of economical programs will be needed in order to improve the economic crisis within Canada brought upon by USMCA. The government will establish a program to help affected businesses ease into the economical change. This will benefit specific businesses in allowing them to adapt to changing business culture and meet consumer demands.

Finally, the federal government will try its best to continue negotiating tariffs associated with soft lumber, aluminum, and steel with the United States of America in order to establish a stronger trade bond and ideal taxation amounts in addition to looking at further expanding Canadian goods into foreign markets with additional trade deals.
